

BRITISH CHESS GDPR PRIVACY NOTICE

This Privacy Notice is provided to you by “British Chess” who are the data controller for your personal data.

Your personal data – what is it?

Personal data is any information about a living individual which allows them to be identified from that data. The processing of personal data is governed by legislation in the United Kingdom including the General Data Protection Regulation (GDPR).

British Chess collects and uses information about players and their parents who have entered their junior chess events. This is used for the events and to inform about future chess events.

This personal information must be dealt with properly and securely however it is collected, recorded and used – whether on paper, in a computer, or recorded on other material – and there are safeguards to ensure this in the GDPR.

British Chess regards the lawful and correct treatment of personal information as very important to the successful and efficient performance of its functions, and to maintain the confidence of those with whom it deals.

To this end British Chess fully endorses and adheres to the Principles of Data Protection as set out in the GDPR.

Purpose

The purpose of this policy is to ensure that those involved with the activities of British Chess are clear about the purpose and principles of Data Protection and to ensure that British Chess has guidelines and procedures in place which are consistently followed.

Failure to adhere to GDPR is unlawful and could result in legal action being taken against British Chess or its volunteers handling data.

Principles

Data users must comply with the data protection principles of good practice which underpin GDPR. To comply with the law, information must be collected and used fairly, stored safely and not disclosed to any other person unlawfully.

Your rights and your personal data

You have the following rights with respect to your personal data. When exercising any of the rights listed below, in order to process your request we may need to verify your identity for your own security.

The right to access personal data we hold on you

At any point you can contact us to request details of the personal data we hold on you and who has access to it. Once we have received your request we will respond within one month.

There are no fees or charges for the first request but additional requests for the same personal data or requests which are manifestly unfounded or excessive may be subject to an administrative fee.

The right to correct and update the personal data we hold on you

If the data we hold on you is out of date, incomplete or incorrect, you can inform us and your data will be updated.

The right to have your personal data erased

If you feel that we should no longer be using your personal data, or that we are unlawfully using your personal data, you can request that we erase the personal data we hold.

When we receive your request we will confirm whether the personal data has been deleted or the reason why it cannot be deleted (for example because we need it to comply with a legal obligation).

The right to object to the processing of your personal data or to restrict it to certain purposes only.

You have the right to request that we stop processing your personal data or ask us to restrict processing.

The right to data portability

You have the right to request that we transfer some of your data to another controller. We will comply with your request, where it is feasible to do so, within one month.

The right to withdraw consent

You have the right to withdraw your consent at any time to any processing of data for which consent was obtained. You can withdraw your consent easily by email.

Further processing

If we wish to use your personal data for a new purpose not covered by this Privacy Notice then we will provide you with a new notice explaining this new use prior to commencing the processing and setting out the relevant purposes and processing conditions. Where and whenever necessary we will seek your prior consent to the new processing.

Changes to this notice

This Privacy Notice will be kept under regular review and we will place any updates on the British Chess website (www.britishchess.co.uk). This Notice was last updated in June 2018.
